The Rose Bowl Trophy is awarded annually to the winning garden in the 'Standard Garden' category and in 2017 Mr. and Mrs. Roberts were successful with Mr. Holt winning the Barrack Trophy for the Container sized garden. Who knows, there could be a judge looking at your efforts in the summer of 2018 Watch the notice boards for results during August and the presentation will take place on 4th September.

Chairman's Report: 2017 - 2018. And so another year has passed with ever increasing speed and the time has come for me to prepare this report, reflecting on the events of 2017.

- In co-operation with the Parochial Church Council and generous funding from Historic England, the much needed restorative work has finally begun on the Church Wall. Hopefully, therefore, this will mean that over the next few years our monthly agenda items will be lighter, although no doubt the issue will soon be replaced by something equally as pressing. Hopefully in 12 months' time the issue of the Market Place improvements and the Clinton Park footpath link will have been resolved, although maybe that's just wishful thinking. Similarly it would be pleasing to have had concerns over car parking charges, both in Tattershall and Coningsby, permanently and gratuitously, resolved.
- Probably the most notable change of the last year is that the parish council now finds itself without a fixed and permanent base, the lease of the parish office having just 30 days to run. Nevertheless, we are fortunate to have secured the long term use of the village hall for our monthly meetings and the clerk's mobile office, coupled with the storage of essential council documentation within the village, should mean that, on a day-to-day basis, things will be largely unchanged. This does, however, emphasise the need for us all to remember that the parish council is the branch of local government closest to the electorate. It cannot be denied that there are aspects of the role of a parish councillor which have a potentially comic, Dibleyesque note, but the overriding feature is that the parish council is a separate, legal, corporate entity which was first created by the Local Government Act in 1894 and is now largely governed by consolidated legislation from 1972. This means that we are important representatives of the residents, electorate, business operators, visitors and others connected with village life and should be a first point of call to many. That point of contact is not limited to 9 to 5,

Monday to Friday within a particular office but rather 24 hours a day, seven days a week, every day of the year with omnipresence.

- We still have one vacancy to fill, a councillor for Tattershall, and I can perhaps do no more than once again express the hope that we will end the forthcoming year with a full body of representatives. That said, is was a great pleasure to welcome back to our congregation our most recently appointed councillor for his second stint in the role.
- May I, on behalf of all the parish councilors, express thanks to the County and District Council Councillors and the representatives of Lincolnshire Police who have attended our meetings to ensure we are and remain fully appraised of significant and pertinent developments at higher levels of local government and public service. In addition, I would personally like to thank our clerk for trying, with occasional success, to keep me on the straight and narrow but more importantly for her hard work in helping us all, and also to those councilors who have given valiant service, over the last 12 months and made the year so rewarding.
