

Chairman's Report: 2015 – 2016

It hardly seems possible that it's 12 months since I gave the last annual report. It really is true that time flies by faster as the years advance.

To some extent we end the year in a manner similar to its beginning, with vacancies on the council. However, we have been fortunate to have been joined by two new councilors this year and I am sure that the long-standing councilors will agree we are heartened by the enthusiasm which their presence has brought.

As ever we face some certainties; the frailty of the church wall is an item which has concerned us all deeply and featured heavily on our agendas for some time and on the assumption that suitable funding sources are found to ensure the protection of this most valuable of historic monuments will, no doubt, continue to do so for the foreseeable future. Perhaps more poignantly, however, is the imminent loss of the council's long term home when the lease of the parish office expires in May 2018. This will be probably the most pressing of challenges with which we will be presented in the near future and I trust that Tattershall with Thorpe Parish Council will be

able to work closely with East Lindsey District Council in finding a permanent long term venue within the curtilage of our combined villages to ensure the continued presence of the community access point.

- Perhaps one of the greatest losses the community has experienced over the last 12 months is the closure of the library. We are, nevertheless, fortunate to have secured the mobile library service and are particularly grateful to Cllr Mrs. Harkus for her sterling efforts which have resulted in significantly greater hours being made available to our community than originally scheduled.
- I would also like to place on record our thanks to Cllr Burr for so nobly taking on the somewhat arduous task of dealing with the council's website, which is now not only more user friendly but also is becoming informative as the old is integrated with the new. Perhaps that provides a valuable lesson for us all.
- The introduction of the latest piece of gadgetry is, of course, the electronic speed monitoring device, which hopefully will prove to be more durable than the fixed signs which have been erected through the villages but which have been found to have a somewhat limited lifespan.
- Once again Cllr Mrs. Dawson and I were privileged to attend the Commanding Officer's annual reception at RAF Coningsby during the warm summer months, the pleasure of which was only surpassed by the joy of turning on the lights on the Christmas tree in December.
- Finally, as my term of office comes to an end, I would once again like to thank all of those present round this table, but most emphatically our clerk, for their hard work over the last year and for having helped to make the last 12 months so rewarding.

NOTES FROM THORPE

Prior to the commencement of the 2015 Annual Assembly at Thorpe Camp there was a presentation given on the major benefit to the community that would be had if Thorpe had a defibrillator located in the village. The talk and demonstration was given by East Midlands Ambulance Service. The defibrillators located at both Coningsby and Tattershall were deemed to be far too distant to be of any use.

At the well-attended meeting that followed it was overwhelmingly agreed that Thorpe should commence fund raising in order to purchase one at the earliest opportunity. Some of the funding was provided by the County, District and Parish Councils. Many residents gave donations, and with the help of the profits from the car boot stall run by residents and also the proceeds from an open garden railway day donated by another resident our target was met.

The defibrillator was purchased and put on display at our annual autumn village event. This year it was a Harvest Supper with the speaker being the Lincoln Town Crier.

The defibrillator is now installed at Koblenz, Main Road, Thorpe [opposite the Blue Bell]. In the event of an emergency requiring the defibrillator simply ring 999 and the telephone operator will advise the code to open the cabinet in order to remove the appliance.

Remembrance Day Service at the War Memorial was again very well attended. The tea, coffee and biscuits provided by Bob and Jonquil afterwards being much appreciated on a cold winter's morning.

Christmas saw the final outing for our poor old artificial tree. It has served us well for many years and it is now time to pension it off.

Next year we can all look forward to a new real live tree.
